Daytime Playtime Enrichment Center Party Policies

1. A parent or caregiver is responsible for supervising ALL children during ALL times of the above stated party. Daytime Playtime staff is not responsible for providing supervision for any child during party festivities. A responsible adult must be present for every three children present.
2. Outside food and drinks are not allowed. Pizza, cupcakes, juice, soda and water are all provided in the party package or available for purchase.
3. Our facility is equipped with 2" thick antibacterial mats and soft/age-appropriate play equipment. Both the parent and child must remove their shoes before entering the play floor. Please wear socks if possible.
4. Keeping everyone healthy and safe are two major goals at Daytime Playtime. If you notice ANY signs of illness or know they were recently exposed to an illness, please do not bring your child to play at Daytime Playtime. If any child is harming him or herself, other children, staff members have the right to ask the parent to remove that child from the playroom floor.
5. Please be aware that all equipment at Daytime Playtime is designed for children ages 5 and under. Children of any age may attend and participate in party activities. However, it is expected that children over the age of 5 will be gentle and under their parent's control during the party. Please note that any child may be asked to refrain from playing on the equipment if a staff member feels it becomes necessary.
6. Any damage to the equipment or facility due to wrongful use will be the responsibility of the client signed below. In the event that damage does occur, the client will be notified and have the option of paying with the credit card on file or in another manner if desired. **Your card will not be charged without your knowledge.**
